<u>Teacher's Report</u>: J.Roxbury reported pre-planning going well, lots of good discussions & several teachers went to a Google tech conference at the end of June & thought it was excellent. It was well received, they learned & saw a lot & positive comments from everyone that went. Nicole Thompson, 3rd grade, met with someone at UCF about setting up a 3rd & maybe 4th grade art program for this year. To honor the victims of the Pulse shooting, LECS staff & students will be initiating "49 Acts of Kindness" out over our school & into the community. The kick-off will be the 1st Wednesday after school starts. The acts will be grade/age appropriate & the ideas will come from the students. She said we do a lot of community service that goes out of town, but this will all be local. Discussion held.
